

Data Protection Information according to Art. 13, 14 and 21 of the General Data Protection Regulation (GDPR)

Creation of photos, videos and audio recordings at Tag der Neugier 2022

At a public event such as Tag der Neugier 2022, photos, videos or sound recordings, i.e. personal data, are created for the purposes of our public relations work.

Personal data is any information relating to an identified or identifiable natural person. An identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data or an online identifier.

The following information must be provided to you in accordance with Art. 13 of the General Data Protection Regulation (GDPR) when the personal data is collected:

1. Controller

2. Processing purposes and legal basis

Your personal data will be processed in accordance with the provisions of the General Data Protection Regulation (GDPR), the Federal Data Protection Act (BDSG) and other relevant data protection regulations. In the case of photographs, videos or audio recordings, the Art Copyright Act will apply in the event of possible publication thus for the protection of our legitimate interest. The processing and use of the individual data depends on the agreed or requested service. Our contract documents, forms, declarations of consent and other information provided to you (e.g. on the website) contain further details and additions for processing purposes.

3. Press and public relations (Art. 6 para. 1 lit f GDPR)

Photographs, video or audio recordings are created processed for press and public relations work at the Research Centre. If a publication according to §§ 22 and 23 of the Art Copyright Act (KUG) is not relevant, an additional agreement may be made.

4. Categories of personal data processed by us

The following data is collected/created and further processed:

- Photographs
- Video Recordings
- Sound Recordings

5. Who receives the data?

We pass on your personal data within our company to the divisions, who need this data to fulfil their contractual and legal obligations or to implement our legitimate interest. Internet presences of Forschungszentrum Jülich also record presences in social networks such as Facebook, Twitter and Instagram. In addition, individual contents are also posted on Internet platforms such as YouTube. Information on their terms of use can be found in the Research Centre's data protection declaration on the Research Centre's homepage

6. Transfer of your data to a third country or to an international organisation

Data processing outside the EU or the EEA does basically not take place. It is however possible in exceptional cases with various Internet platforms such as YouTube. In these cases, the Research Center checks the adequacy of the level of data protection in the corresponding third country.

7. How long do we store your data?

If necessary, we process your personal data for the duration of our business relationship or the duration of publication. The specified periods for storage or documentation are up to ten years after the end of the business relationship or the pre-contractual legal relationship. Ultimately, the storage period is also assessed according to the statutory limitation periods and it is regularly checked whether data can be deleted.

8. To what extent is there automated decision-making in individual cases (including profiling)?

We do not use purely automated decision-making procedures pursuant to Article 22 GDPR. Should we use these procedures in individual cases, we will inform you separately.

9. Your privacy rights

You have the right of Information pursuant to Art. 15 GDPR, the right of rectification pursuant to Art. 16 GDPR, the right of deletion pursuant to Art. 17 GDPR, the right of restriction of processing pursuant to Art. 18 GDPR and the right of data transfer pursuant to Art. 20 GDPR. In addition, there is a right of appeal to a data protection supervisory authority (Art. 77 GDPR).

10. Scope of your obligations to provide us with your data

You only need to provide data which is necessary for the establishment and execution of a business relationship or for a pre-contractual relationship with us or which we are legally obliged to collect. Without this data, we will generally not be able to conclude or execute the contract. This may also refer to data required later within the framework of the business relationship. If we also request data from you, you will be informed of the voluntary nature of the information separately.

11. Your right to appeal to the competent supervisory authority

They have the right to appeal to the data protection supervisory authority (Art. 77 GDPR). The supervisory authority responsible for us is:
